POPIA - ACT (PROTECTION OF PERSONAL INFORMATION)

The implementation date of the Protection of Personal Information Act, 4 of 2013 ("POPIA"), is already being implemented on 30 June 2021. This Act brings about some changes.

The Santa Gertrudis Society is required to obtain your consent to the use of your personal information. You are entitled to refuse the use or dissemination of such information.

If you choose or agree that your personal information (namely: your name, cell phone number, address, e-mail address) is notable to any person, the Society will use it in membership lists, any brochure or publications, inquiries, catalogues, etc. If you refuse, no information of yours will be passed on or provided to third parties.

In order to ensure that you are respected, it is impossible to give permission to the Society only in certain cases. The principle of "all or nothing" applies in order to eliminate any confusion.

We request all Santa Gertrudis members of the Society not to use, under any circumstances or for any reason whatsoever, any personal information, from a third party, without obtaining the consent of the person concerned.

The Society takes no responsibility for persons who violate this Act. It also applies to all information on all documentation of the Santa Gertrudis Society.
